CITY OF LAGRANGE, GEORGIA REGULAR MEETING OF THE MAYOR AND COUNCIL

January 12, 2021

Present: Mayor Jim Thornton; Council Members Mark Mitchell, Tom Gore, Nathan Gaskin, Jim Arrington and Willie Edmondson

Absent: Council Member LeGree McCamey

The meeting was called to order by Mayor Thornton, the invocation was given by Rev. Michael Jackson of Confidence Missionary Baptist Church, and Mayor Thornton led the Pledge of Allegiance to the Flag.

On a motion by Mr. Arrington seconded by Mr. Gaskin, Council unanimously approved the minutes of the regular Council meeting held on December 22, 2020.

A public hearing was held to receive comments on a request to zone property located at 71 Busch Drive to G-I (General Industrial). No comments were received and Council heard the first reading of the following ordinance:

AN ORDINANCE

AN ORDINANCE OF THE MAYOR AND COUNCIL OF THE CITY OF LAGRANGE TO AMEND THE CODE OF THE CITY; TO AMEND THE ZONING MAP AND ORDINANCES OF THE CITY SO AS TO CLASSIFY THE USE ZONE OF REAL ESTATE TO BE ANNEXED INTO THE CITY LOCATED ON BUSCH DRIVE AND OWNED BY YOGAO, LLC; TO REPEAL CONFLICTING ORDINANCES; TO FIX AN EFFECTIVE DATE; AND FOR OTHER PURPOSES.

Mr. West presented information to the Council regarding a Board of Planning and Zoning Appeals recommendation to rezone property located at 111 and 115 Fort Drive from R-3 (Residential) to C-3 (General Commercial). On a motion by Mr. Arrington seconded by Mr. Edmondson, Council voted unanimously to call for a public hearing to be held on February 9, 2021 at 5:30 p.m.

Ms. Kelsey presented copies of the December financial statements and payment of bills over \$2,000 for Council's information.

Ms. Kelsey reported to the Council that it was time once again for the Comprehensive Plan Update. On a motion by Mr. Edmondson seconded by Mr. Gaskin, Council voted unanimously to call for a public hearing to be held on January 26, 2021.

On a motion by Mr. Mitchell seconded by Mr. Edmondson, Council voted unanimously to adopt the following Resolution:

A RESOLUTION ESTABLISHING QUALIFYING FEES FOR 2021 MUNICIPAL ELECTION

WHEREAS, O.C.G.A. Sec. 21-2-131 (a)(1) requires that qualifying fees for public offices be fixed and published; and

- WHEREAS, O.C.G.A. Sec. 21-2-131 (a)(1) requires that the governing body of a municipality fix and publish qualifying fees for each of its offices not later than February 1 the year the general election is to be held; and
- WHEREAS, O.C.G.A. Sec. 21-2-131 (a)(1) states the qualifying fee for each office to be filled in the upcoming election shall not be more than three (3) percent of the income derived from such office paid in the preceding calendar year.
- NOW, THEREFORE, BE IT HEREBY RESOLVED that the Mayor and Council of the City of LaGrange, Georgia, do hereby fix the qualifying fee for the office of Mayor at Three Hundred Sixty (\$360.00) dollars and Council Member at Two Hundred Eighty Eight (\$288.00) dollars do hereby publish the same.

Council heard the first reading of the following ordinance:

AN ORDINANCE

AN ORDINANCE OF THE MAYOR AND COUNCIL OF THE CITY OF LAGRANGE TO ANNEX TO THE CITY CONTIGUOUS REAL PROPERTY OWNED BY YOGAO, LLC AND LOCATED AT 71 BUSCH DRIVE; TO REPEAL CONFLICTING ORDINANCES; TO FIX AN EFFECTIVE DATE; AND FOR OTHER PURPOSES.

On a motion by Mr. Gore seconded by Mr. Arrington, Council voted unanimously to approve the following ordinance:

AN ORDINANCE

AN ORDINANCE OF THE MAYOR AND COUNCIL OF THE CITY OF LAGRANGE TO AMEND THE CODE OF THE CITY; TO AMEND THE ZONING ORDINANCE OF THE CITY SO AS TO EXEMPT RESTAURANTS AND SPECIAL EVENT CENTERS WITHIN THE C-2 AND C-3 ZONING DISTRICTS FROM THE DURATIONAL RESTRICTIONS FOR PORTABLE CONCESSION STANDS; TO MODIFY DURATIONAL RESTRICTIONS AS TO ALL PORTABLE CONCESSION STANDS; TO REPEAL CONFLICTING ORDINANCES; TO FIX AN EFFECTIVE DATE; AND FOR OTHER PURPOSES.

THE MAYOR AND COUNCIL OF THE CITY OF LAGRANGE, GEORGIA, HEREBY ORDAIN AS FOLLOWS:

SECTION 1:

That subparagraph c. of subsection (2) of Section 25-35-64 be amended by deleting said subparagraph, in its entirety, and inserting in lieu thereof a new Section 25-35-64 (2) c. to read as follows:

"c. Up to one (1) portable concession stand, provided that it has been approved by the health department; it is located within one hundred (100) feet of a bathroom facility containing a toilet and wash sink that has been approved for public use by the owner; and the unit is not located in a required parking space and will not interfere with safe traffic circulation on the site. Once a portable concession stand has been used to conduct business or has otherwise been placed on a lot within this zone, it may remain on said lot for up to three (3) days or portions of days per week."

SECTION 2:

That subsection (2) of Section 25-35-64 be amended by inserting therein a new subparagraph d. to read as follows:

"d. Notwithstanding any provision herein to the contrary, a portable concession stand may be removed from and returned to a particular lot during nonbusiness hours during the three (3) day period of limitation referenced herein. Merchants participating in events on public property sanctioned and approved by the Downtown LaGrange Development Authority or the Troup County Parks and Recreation Commission shall be exempt from the durational requirements of this section. Also, a portable concession stand operating on the lot of an existing and operating restaurant (as defined in Section 30-20-96) or special events center shall be exempt from said durational requirements."

SECTION 3:

That subparagraph c. 1. of subsection (4) of Section 25-35-65 be amended by deleting said subparagraph, in its entirety, and inserting in lieu thereof a new Section 25-35-65 (4) c. 1. to read as follows:

- "c. Up to one (1) portable or stationary concession stand, provided that it satisfies the following applicable requirements:
 - 1. Up to one (1) portable concession stand, provided that it has been approved by the health department; it is located within one hundred (100) feet of a bathroom facility containing a toilet and wash sink that has been approved for public use by the owner; and the unit is not located in a required parking space and will not interfere with safe traffic circulation on the site. Once a portable concession stand has been used to conduct business or has otherwise been placed on a lot within this zone, it may remain on said lot for up to three (3) days or portions of days per week. Notwithstanding any provision herein to the contrary, a portable concession stand may be removed from and returned to a particular lot during nonbusiness hours during the three (3) day period of limitation referenced herein. Merchants participating in events on public property sanctioned and approved by the

Downtown LaGrange Development Authority or the Troup County Parks and Recreation Commission shall be exempt from the durational requirements of this section. Also, a portable concession stand operating on the lot of an existing restaurant (as defined in Section 30-20-96) or special events center shall be exempt from said durational requirements."

SECTION 4:

All ordinances or parts of ordinances in conflict with the provisions of this ordinance shall be and the same are hereby repealed.

SECTION 5:

This ordinance, after adoption by the Council and upon approval by the Mayor, shall become effective immediately.

AN ORDINANCE

AN ORDINANCE OF THE MAYOR AND COUNCIL OF THE CITY OF LAGRANGE TO AMEND THE CODE OF THE CITY; TO AMEND THE SIGN ORDINANCE SO AS TO REMOVE WINDOW AREA RESTRICTIONS FOR GROUND FLOOR WINDOWS OF VACANT BUILDINGS WITHIN THE C-2 DISTRICT; TO REPEAL CONFLICTING ORDINANCES; TO FIX AN EFFECTIVE DATE; AND FOR OTHER PURPOSES.

THE MAYOR AND COUNCIL OF THE CITY OF LAGRANGE, GEORGIA HEREBY ORDAIN AS FOLLOWS:

SECTION 1:

That subsection (o) of Section 25-10-16 of the code be deleted, in its entirety, inserting in lieu thereof a new subsection 25-10-16 (o) to read as follows:

"(o) Window signs. Window signs on residentially zoned or used properties (including OIR-1). Also prohibited are individual or aggregate window signs exceeding twenty (20) percent of the window area per building elevation for all other districts, except for the ground floor windows of vacant buildings within the C-2 district, for which there shall be no window area restrictions."

SECTION 2:

All ordinances or parts of ordinances in conflict with this ordinance are hereby repealed.

SECTION 3:

This Ordinance after adoption by the Council and approval by the Mayor shall become effective immediately.
